**Minimum Wage to Increase by Over a \$1 on Jan. 1st 2023**

The Arizona Industrial Commission has set the new Arizona minimum wage at \$13.85 per hour beginning January 1, 2023. This represents an increase of \$1.05 in hourly wages, or \$2,184 annually for a full-time worker over the current wage of \$12.80. The wage was calculated by applying the increase in the Consumer Price Index (CPI) from August 2021 to August 2022. That increase was 8.3%. An 8.3% increase translates to \$1.06, however the statute requires the commission to round the wage to the nearest nickel, resulting in a \$1.05 increase for 2023.
