NATIVE District will go with the lowest bid. Items for price quotes are required to have the same amount of items and the same model. Vendor bids will be compared.

A W9 must be submitted for new vendors. NATIVE District needs correct remittance payment address.

  - Payment will be processed and purchase order will be closed
- \*Tagging of Equipment
  - Equipment over \$250.00 will be tagged by CTE Director Jonathan Yazzie
- Questions & Concerns:
  - Tyrell Harvey, Window Rock CTE Director and Clyde McBride, Monument Valley CTE Director are requesting Cooperative Vendor List and to have access to Visions under NATIVE District. Mr. Gabriel Yazzie, NATIVE Business Manager will contact Visions to verify if CTE Directors can have access under Vision.
  - The \$10,000 purchases are calculated by 'like items' not by vendor
  - Large capital items vendors require to use a lift and these items will be delivered to school sites. Tuba City & Pinon are requesting items to be delivered to school site warehouse.
  - Site CTE Directors will need to send a purchase order to site Warehouse
  - Capital equipment that are purchased through NATIVE District should have NATIVE tags

Board member Zhonnie thanked the CTE Directors and staff for attending. How can NATIVE District help the CTE Directors with the teachers. NATIVE District would like to see improvement in the programs, "we want to help".

Board member Curtis, "We are all held accountable teaching our students to run the programs at each school sites. We all need to be in compliance with the programs. NATIVE Board members approve allocations to school sites to help with CTE programs. Professional development will be provided through NATIVE District or AZ Department of Education. A CTE teacher who are coaches affects CTE Programs. CTE teachers are not 100% focus on CTE Program - CTE Teachers need to be committed. Get programs in compliance. Low enrollment at all school sites. What happens to funding if the enrollment becomes too low? Improvement Plan may need to be set up. There are struggles at all sites. Need to collaborate with each other to improve on all programs. Work with one another."

Possibly use CTE teacher as trainers from school sites. Incentives for teachers through Perkins Grant is possible.
