Why: NATIVE District office has seen recently that when it comes to meal rates, the current meal rates are not sufficient in that NATIVE students and staff have to pay for meals using their own funds because not enough funding is provided due to higher meal prices.

Recommended change:

- Current breakfast rate: \$15; the amount will remain the same at \$15
- Current lunch rate: \$15; increase meal rate to \$20
 Current dinner rate: \$20; increase meal rate to \$32
